The Active Threat

Presenter Name: Jedd Bradley

Presenter Bio-

Jedd Bradley has been in law enforcement for over 18 years and is still serving as an officer for the City of De Pere in Wisconsin. He is a 12-year veteran on the Brown County SWAT team and has taught hundreds of police officer's tactics on how to respond to an active shooter incident. He was one of the instructors that trained over 450 officers from 11 different agencies on the MACTAC (Multi-Assault-Counter Action Capabilities). In 2019 Jedd was one of the lead tactical trainers that trained over 500 police, fire and EMS on responding to an active shooter incident in Brown County. Jedd is one of the lead firearms instructors for his agency and continues to train officers on a daily basis on how to respond to active threats to the public.

Jedd recently in 2017 was sent to the National Tactical Officers hostage rescue training. In 2016 he was trained by FEMA in event security planning for the public safety professionals. Also in 2016 he trained over 1,000 school employees from two different school districts in the ALICE active shooter training. In 2014 the American Crime Prevention Institute in Louisville Kentucky certified Jedd as a crime prevention specialist.

In 2018 Jedd was certified by the Texas State University Advanced Law Enforcement Rapid Response Training Active Shooter Level II.

Jedd is passionate about how the public and civilians need to be educated on what to do in an active shooter incident.

Since 2014 Jedd has trained thousands of employees from all over the country in what to do in an active shooter situation.

This presentation will be a brief history of active shooter incidents from across the nation. What worked what didn't and how law enforcement has changed responses to these incidents.

It will also show the public how to survive an incident and what to do and how to do it. It will describe and show tactics and simple applications when presented in a situation like this.

What's Up at OSHA and When OSHA Comes Calling

Eric E. Hobbs is a Shareholder with and Chair of the 55-lawyer Workplace Safety and Health Practice Group of Ogletree Deakins, one of the nation's leading law firms representing employers in labor and employment matters. He also serves as a member of the firm's Drug Testing and Manufacturing Industry Practice Groups. In his role as attorney and strategic advisor, Mr. Hobbs engages in a nationwide labor and employment law practice, which includes the representation of employers in traditional labor and employment matters, OSHA and MSHA enforcement and litigation, and employment counseling and litigation.

Mr. Hobbs is a Past Employer Co-Chair of the American Bar Association's Occupational Safety and Health Law Committee. He is a co-author of and chapter editor for Bloomberg/BNA's Occupational Safety and Health Law treatise, the "bible" for practitioners and judges in the area, and author of the chapter on occupational safety and health law in the Wisconsin State Bar's Wisconsin Employment Law treatise. Mr. Hobbs also writes and speaks frequently to employer groups, attorneys and judges around the country. In the Fall of 2018, for a fourth time, he addressed the Commissioners and Judges of the U.S. Occupational Safety and Health Review Commission at its Judicial Conference at the invitation of the Commission's Chair and Chief Judge. He also testified before Congress on "A More Effective and Collaborative OSHA: A View from Stakeholders" in February of 2018.

In 2014, in recognition of his long and distinguished career, Mr. Hobbs was elected as a fellow in the College of Labor and Employment Lawyers. That same year, the Pulp and Paper Safety Association presented him with its Outstanding Service Award. Mr. Hobbs also is a Fellow of the Wisconsin Bar Foundation. And, in 2015, the Milwaukee County Commission for Persons with Disabilities established the "Eric Hobbs Award" in recognition of Mr. Hobbs's 20 years of service as a commissioner, 10 as chairperson. Peers and business leaders also have recognized him as one of The Best Lawyers in America every year since 2009 and as one of Chambers' Leading Lawyers for Business in the areas of labor, employment and worker's compensation law.

In his leisure time, Mr. Hobbs enjoys training and competing in Tae Kwon Do, in which he holds a second-degree black belt, and singing in his community and church.
